Highlights of the National Budget Framework Paper FY2021/22 Budget

Key highlights:

- a. Real GDP Growth:
 - The economy grew by 2.9% in FY 2019/20 which is lower than 6.8% recorded in FY 2018/19.
 - Economic growth in the FY 2020/21 is projected in the 2-3% range and is expected to improve further to between 4-5% in FY 2021/22.
- b. <u>Fiscal deficit</u>: The fiscal deficit as % of GDP estimated at **10.7% for FY 2020/21** up from 7.2% in FY 2019/20, but projected to decline to 7.0% in 2021/22. This is in contradiction of the Charter for Fiscal Responsibility (CFR) objectives of the period FY2016/17–FY2020/21, which is "to maintain the fiscal deficit as a proportion of GDP to below 3 %".
- c. <u>Public Debt:</u> Total Public Debt stood at USD 15.27 billion (of which USD 10.45 billion is external and USD 4.82 billion is domestic) as at June 2020. This is equivalent to 41.0% of GDP in nominal terms and 31.8% in PV terms.
 - Debt is projected to increase further over the near term amounting to 49.9% of GDP by end June 2021, and peaking at 54.1% in 2022/23.
 - Debt service (interest payments 10.9%, External debt repayments (amortization) 4.0% and domestic debt refinancing 18.7%) are projected to take up **33.6% of the proposed**FY 2021 /22 budget.
- d. Efficiency Measures from FY 2020/21: UShs 351.6 billion (Recurrent UShs. 267.9 Billion and Development UShs. 83.72 Billion) savings (generated through budget cuts of non-essential spending) in FY 2020/21 would be maintained in FY 21/22. This is in addition to the one-off savings ²amounting to Ushs. 945.1 Billion. The Total Efficiency Savings is projected at UShs. 1,296.7 Billion.
- e. <u>Fiscal Strategy</u>: Fiscal operations in FY 2021/22 and the medium term will focus on policy interventions to sustain recovery from the socioeconomic setbacks caused by the COVID-19 pandemic as well as the development objectives set out in the NDP III.

- f. Resource Envelope. The total resource envelope, in FY 2021/22 is projected at UShs. **45,658 billion** an increase of UGX 163.4 billion when compared with FY 2020/21. See Figure 1 and Table 1.
 - Total Resource Envelope is projected to increase **by 0.4%** compared to FY21, with domestic resources contributing 75% and external resources 25%. External funding is expected to decline by 1.5% compared to FY21, but budget support /grants is projected to increase by 26%. However, the increase in grants is unlikely given the half year performance (July –Dec, 2020), where only 40% of the programmed amount of grants were received by Government, and the negative impact of Covid-19 on the donors.
 - Interest payments to increase by 22% (UShs 911 Bn); increasing the share of national budget to 14.4% in FY 22 from 11.2% in FY 21
 - Domestic Refinancing will increase by 14% (UShs 8,547 Bn) and take over 19% of the total resource envelope.
 - Domestic arrears payments projected to reduce by 11% (UShs 50 Bn) compared to FY21. Domestic arrears amounted to UGX 3.34 trillion in June 2019 which was 2.7% of GDP. This has potential implications for the stimulation of the domestic economy given the Covid-19 pandemic.
 - Appropriation in Aid (AIA) projected to decline by 19% with the central government AIA declining by 24%; an indication on limited efforts towards revenue mobilisation by central government agencies.
 - The UShs 481.7 billion BoU Recapitalization was not supported by BoU, since the CB's operational capital is not impaired.



g. <u>Additional required funds for FY 2021/22.</u> Amount to **Ushs 5,994.28 billion.** However, after review, table 2 shows the critical areas for additional funding. These will be covered through tax policy and administrative measures that are still under review.



 Though the classified expenditures are covered, they will still get higher portion of the supplementary budgets.

h. FY 2021/22 Budget allocations:

- Governance & Security (22.4%); Human Capital Dev't (20.4%); Integrated Transport Infrastructure and Services (17.3%); Interest Payments (14.4%) will take three-quarters of the total budget). The share are calculated excluding Arrears, Debt (external amortisation & domestic financing).
- Budgets (in nominal terms) for Agro-Industralisation; and Human Capital Dev't declined by 1.7% and 4% compared to FY21 respectively.
- Budget (in nominal terms) for Integrated Transport Infrastructure and Services to increase marginally by 1.6%, with UNRA getting a 30% increment.
- The biggest increases in sectoral budget allocations in FY22 compared to FY21 are: Sustainable Urbanization & Housing (172%); Sustainable Dev't of Petroleum Resources (56%); and Interest Payments (23%). While the biggest losers are: Digital Transformation (37%); Community Mob. & Mindset Change (32%); Manufacturing (30%); Sustainable Energy Dev't (30%); and Regional Dev't (27%). 
